ORDINANCE NO. 87 - 02

AN ORDINANCE AMENDING ORDINANCE NO. 86-04 OF THE CODE OF ORDINANCES OF LIBERTY COUNTY, FLORIDA, KNOWN AS THE LICENSING OF PERSONS TO CARRY CONCEALED PISTOLS OF LIBERTY COUNTY, FLORIDA; AMENDING SECTION 3.(a)(3) THEREOF PROVIDING FOR APPLICATION FEE BY STRIKING SAME AND SUBSTITUTING THEREFOR A NEW SECTION 3.(a)(3) AS FOLLOWS -- "DELIVER THE COMPLETED APPLICATION, TOGETHER WITH AN APPLICATION FEE IN AN AMOUNT TO COVER ALL COSTS TO THE SHERIFF OF LIBERTY COUNTY FOR HIS INVESTIGATION, TO THE OFFICE OF THE CLERK TO THE BOARD, AND SUBMIT HIMSELF TO FINGERPRINTING BY THE SHERIFF'S OFFICE."; AMENDING SECTION 8.(c) THEREOF PROVIDING FOR PAYMENT OF RENEWAL FEE BY STRIKING SAME AND SUBSTITUTING THEREFORE A NEW SECTION 8.(c) AS FOLLOWS -- "PAYMENT OF A RENEWAL FEE IN AN AMOUNT TO COVER ALL COSTS TO THE SHERIFF OF LIBERTY COUNTY FOR THE UPDATED RECORD CHECK PROVIDED FOR IN SECTION 8.(a)"; AND PROVIDING EFFECTIVE DATE.

BE IT ENACTED BY THE PEOPLE OF LIBERTY COUNTY, FLORIDA:

ARTICLE I - That Section 3.(a)(3) of Ordinance No. 86.04 adopted by the Board of County Commissioners of Liberty County, Florida on second and final reading on October 7, 1986 pertaining to application fee is hereby amended by striking same and substituting the following:

"SECTION 3.(a)

(3) Deliver the completed Application, together with an application fee in an amount to cover all costs to the Sheriff of Liberty County for his investigation to the office of the Clerk to the Board, and submit

himself to fingerprinting by the Sheriff's Office."

ARTICLE II - That Section 8.(c) of said Ordinance No. 86.04 pertaining to renewal fee is hereby amended by striking same and substituting the following:

"SECTION 8.

(c) Payment of a Renewal Fee in an amount to cover all costs to the Sheriff of Liberty County for the updated record check provided for in Section 8.(a)"

ARTICLE III - Effective Date.

This Ordinance shall take place immediately upon passage and publication as provided by law.
