

ORDINANCE NO. 92-10

AN ORDINANCE AMENDING LIBERTY COUNTY ORDINANCE NO. 90-02, SO AS TO INCREASE THE FEE CHARGED A BUSINESS ESTABLISHMENT BY LIBERTY COUNTY FOR DUMPING OF A SIX (6) CUBIC YARD CONTAINER AND THE FOUR (4) CUBIC YARD CONTAINER; PROVIDING FOR CONFLICT AND SEVERANCE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Liberty County, Florida hereby finds and determines that it is necessary to increase the fees charged a business establishment for each dumping of the six (6) cubic yard containers and each dumping of the four (4) cubic yard containers in order to accurately reflect the cost of the services; and

WHEREAS, a charge of Ten (\$10.00) Dollars for dumping of each six (6) cubic yard container and a charge of Seven (\$7.00) Dollars for dumping of each four (4) cubic yard container has been charged for some time without an amendment to the ordinance establishing said charge;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LIBERTY COUNTY, FLORIDA, that:

Section 1. Increase in Dumping Fee. Section 6 of Liberty County Ordinance No. 90-02 is hereby amended to read as follows:

Section 6. The fees charged a business establishment by Liberty County shall be Twelve and 50/100 (\$12.50) Dollars for each dumping of the six (6) cubic yard container, Nine and 50/100 (\$9.50) Dollars for each dumping of the four (4) cubic yard container, and Nine (\$9.00) Dollars per month for each ninety (90) gallon container. For each residence, the fee shall be Nine (\$9.00) Dollars per month. All fees shall be paid by the twentieth (20) day of the month following the rendering of the collection service.

Section 2. Conflict. All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

Section 3. Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 4. Effective Date. In accordance with Section 125.66, Florida Statutes, a certified copy of this Ordinance shall be filed with the Department of State by the Clerk of the Board of County Commissioners within ten (10) days after

enactment, and this Ordinance shall take effect upon receipt of official acknowledgment that said Ordinance has been filed.
