ORDINANCE NO. 99-04

**AN ORDINANCE OF LIBERTY COUNTY, FLORIDA,
APPOINTING MEMBERS OF THE LIBERTY COUNTY
ENTERPRISE ZONE DEVELOPMENT AGENCY;
PROVIDING SEVERABILITY CLAUSE; PROVIDING
FOR THE APPOINTMENT OF THE CHAIR AND VICE-
CHAIR; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Ordinance adopted on September 9, 1999, established the Liberty County Enterprise Zone Development Agency, consisting of nine (9) members, which shall carry out the economic development and redevelopment purposes of Chapter 290, Florida Statutes; and,

WHEREAS, the Ordinance adopted on September 9, 1999, establishing the Liberty County Enterprise Zone Development Agency, requires that the County Board of Commissioners shall, by Ordinance, appoint nine (9) board members of the Agency;

**BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
LIBERTY COUNTY, FLORIDA, AS FOLLOWS:**

Section 1. **Johnny Eubanks** of the Liberty County Chamber of Commerce is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, to fill a term of four (4) years, commencing on the effective date of this Ordinance and expiring on July 31, 2003.

Section 2. **Jed Heirs** is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, as the representative of a financial or insurance entity, to fill a term of four (4) years, commencing on the effective date of this Ordinance and expiring on July 31, 2003.

Section 3. **Manning Miller** is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, as the representative of a business operating within the Enterprise Zone, to fill a term of one (1) year, commencing on the effective date of this Ordinance and expiring July 31, 2000.

Section 4. **O. B. Shuler** is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, as the representative of a non-profit community-based organization operating within the Enterprise Zone, to fill a term of one (1) year, commencing on the effective date of this Ordinance and expiring on July 31, 2000.

Section 5. A resident of the Enterprise Zone will be appointed by the Liberty County Board of County Commissioners as a member of the Liberty County Enterprise Zone Development Agency no later than sixty (60) days after the first meeting of the Agency, to fill a term of three (3) years, commencing on the effective date of this Ordinance and expiring on July 31, 2002.

Section 6. **Ralph Whitfield** is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, as the representative of the local workforce development board, to fill a term of three (3) years, commencing on the effective date of this Ordinance and expiring on July 31, 2002.

Section 7. **The Sheriff of Liberty County** is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, to fill a term of three (3) years, commencing on the effective date of this Ordinance and expiring on July 31, 2002.

Section 8. **Larry Shuler** is hereby appointed as a member of the Liberty County Enterprise Zone Development Agency, as a representative of the local code enforcement agency, to fill a term of four (4) years, commencing on the effective date of this Ordinance and expiring on July 31, 2003.
