KNOW ALL MEN BY THESE PRESENTS that Edison Johnson and Lucille Johnson his wife, and Clifford C. Land and Boncille Land his wife the owner in Fee simple of the tract of land shown hereon and more particularly described as follows;

Commence at the Southeast corner of Section 1, Township -4-South; Range-9-West and run thence North-440.00 Feet to the Point of Beginning; thence run S 89° 30' 40" W - 1321.84 Feet; thence S 00° 04' E - 194.80 Feet; thence S 89° 31' W - 30.00 Feet; thence N 21° 47' W - 128.69 Feet; thence N 18° 49' W - 131.73 Feet; thence N 89° 35' E - 119.94 Feet; thence N 00° 04' W - 751.10 Feet; thence N 89° 29' 20" E - 1322.84 Feet; thence South-803.90 Feet to the Point of Beginning as above described; have caused said lands to be surveyed and platted hereon and do hereby dedicate to the perpetual use of the public as public highways, and the streets as shown hereon, reserving unto themselves, their heirs or assigns the reversion or reversions of the same whenever abandoned by the public or discontinued by law.


