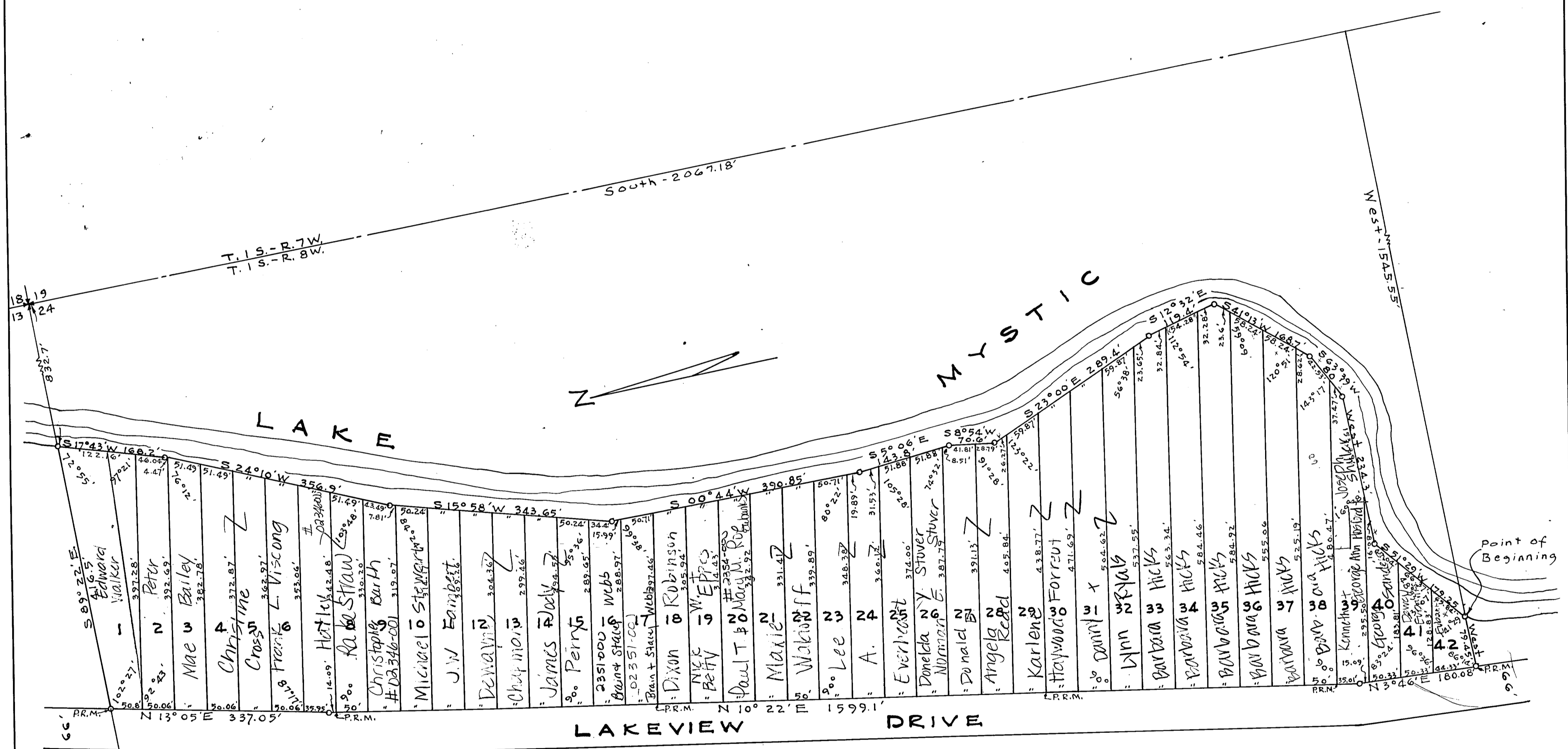


LAKE MYSTIC ESTATES

Know All Men By These Presents, that R.D. Hogue and his wife the owners in fee simple of the tract of land hereon shown and more particularly described as follows: Begin at a point on the Western shore of Lake Mystic, 2067.18' South and 1545.55' West of the N.E. Cor. of Sec. 24, T.15 - R.8W, thence run West 79.45' to the Eastern boundary of the 66' right of way of the public road designated Lakeview Drive, thence along said right of way boundary as follows: North 3° 46' East 180.08', thence North 10° 22' East 1599.1', thence North 13° 05' East 337.05' to the North line of said Sec. 24, thence along the Sec. Line South 89° 22' East 416.5' to the Western shore of Lake Mystic, thence along the shore line in a general Southerly direction to the point of beginning, situate in the N.E. 1/4 of said Sec. 24, have caused said land to be surveyed and platted as shown hereon and do hereby dedicate to the perpetual use of the public as public highways, the streets and drives, as shown hereon, reserving unto themselves, their heirs, successors, assigns, or legal representatives, the reversion or reversions of the same whenever abandoned by the public or discontinued by law.
