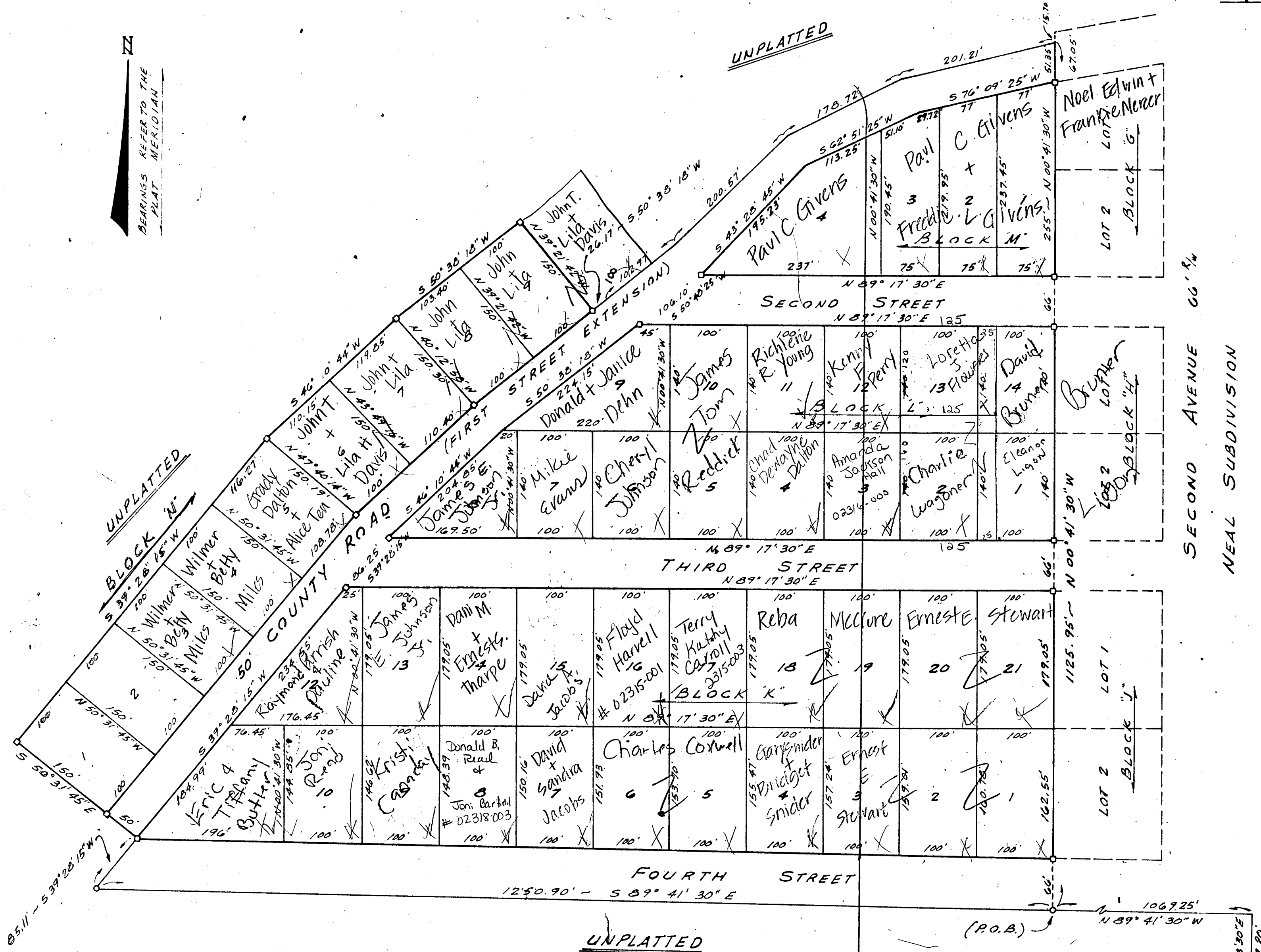


NEAL SUBDIVISION UNIT TWO

COMMENCE AT THE SE CORNER SECTION 12, T15, R.0.W.; THENCE N 00° 12' 30" E, 1779.20' TO THE SOUTH W LINE OF FOURTH STREET, AS PER NEAL SUBDIVISION RECORDED IN THE PUBLIC RECORDS OF LIBERTY COUNTY, FLORIDA; THENCE N 89° 41' 30" W, ALONG SAID W LINE 1069.25' TO THE POINT OF BEGINNING; THENCE N 00° 41' 30" W, ALONG THE EAST LINE OF SAID SUBDIVISION, 125.95' TO A POINT WHICH IS S 00° 41' 30" E, 15.70' OF THE NORTH W LINE OF FIRST STREET, AS PER SAID PLAT; THENCE S 76° 09' 25" W, 201.21'; THENCE S 62° 51' 25" W, 170.72'; THENCE S 43° 28' 45" W, 200.57'; THENCE S 50° 48' 25" W, 102.97'; THENCE S 50° 38' 18" W, 26.17'; THENCE N 39° 21' 42" W, 150'; THENCE S 50° 38' 18" W, 203.90'; THENCE S 46° 10' 44" W, 230'; THENCE S 39° 28' 15" W, 516.27'; THENCE S 50° 31' 45" E, 200'; THENCE S 39° 28' 15" W, 85.11'; THENCE S 89° 41' 30" E, 1250.90' TO THE POINT OF BEGINNING.
