Know all men by these presents that Hoke S. Larkins and his wife Ruth E. Larkins, the owners in fee simple of the lands shown hereon and more particularly described as follows:

Commence at the Southeast corner of Section 26, Township 4 South, Range 9 West and run thence N. 0° 03' 23" E. along the section line 1317.79 feet to the Point of Beginning. From said Point of Beginning run thence S. 89° 54' 27" W. 2641.70 feet, run thence N. 0° 03' 23" E. 1317.79 feet, run thence N. 89° 54' 27" E. 2641.70 feet, run thence S. 0° 03' 23" W. 1317.79 feet to the Point of Beginning, have caused said land to be divided and subdivided as shown hereon and do hereby dedicate to the perpetual use of the public all roads, streets, alleys and other right of ways and all parks and recreation areas and all easements for utilities, drainage and other purposes and for all purposes incident thereto as shown and depicted hereon, reserving, however the reversion or reversions thereof should the same be renounced, disclaimed, abandoned or the use thereof discontinued as prescribed by law by appropriate official action of the proper officials having charge or jurisdiction thereof.


