KNOW ALL MEN BY THESE PRESENTS, that L.H. Shuler and Ruby C. Shuler, his wife, the owners, in fee simple, of the tract of land shown hereon and more particularly described as follows: Commencing at the Northeast Corner of Section 6, Township 1 South, Range 7, West run thence West 2,454.2 feet, thence South 0°28' East 450.25 feet, thence South 88°32' West 308.8 feet, thence South 0°28' East 272.25 feet, thence South 88°32' West 800.0 feet to a point which is the point of beginning. From said point of beginning run thence South 0°34' East 1,377.75 feet, thence North 88°28' East 316.0 feet, thence North 0°34' West 867.0 feet, thence North 88°28' East 25.0 feet, thence North 0°34' West 510.15 feet, thence South 88°32' West 341.0 feet to the point of beginning, have caused said land to be surveyed and plotted as shown hereon and do hereby dedicate to the perpetual use of the public as public highways, the streets as shown hereon reserving unto themselves, their heirs, successors, assigns and legal representatives the reversion or reversions of the same whenever abandoned by the public or discontinued by law.

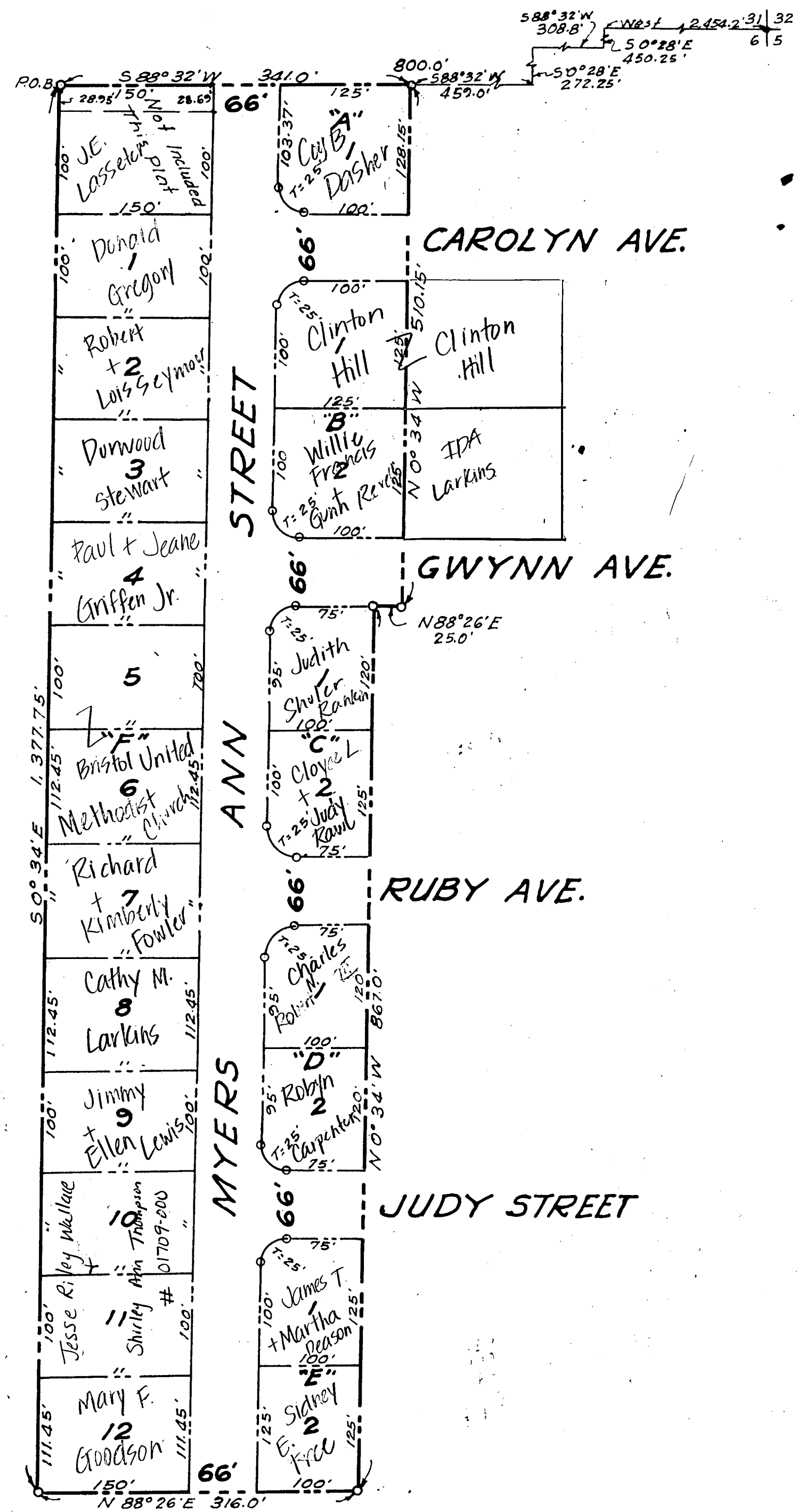

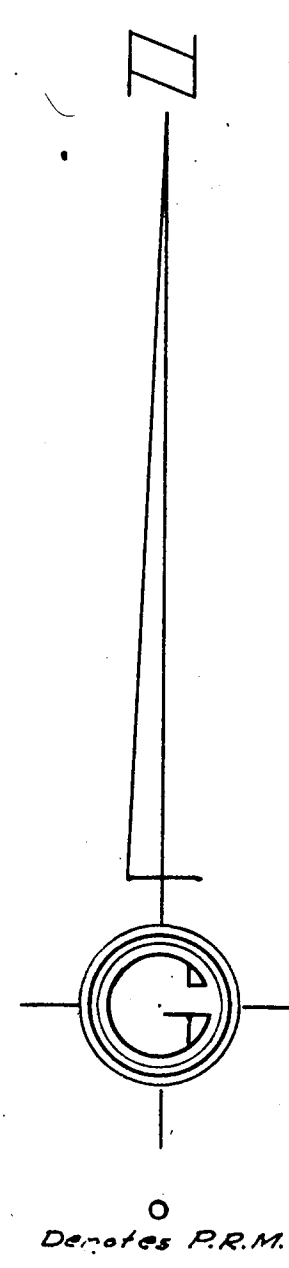
