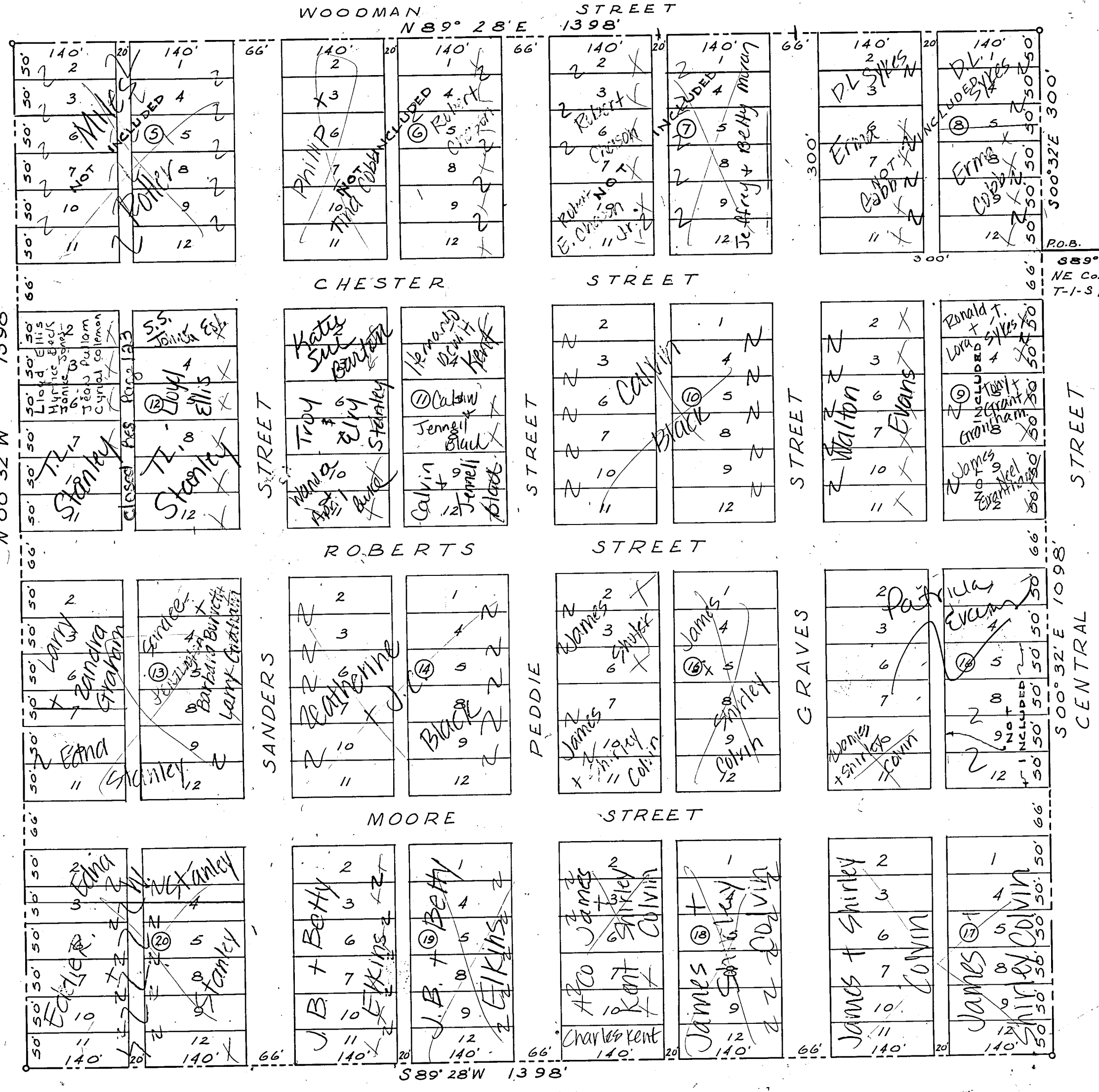
Commence at the Northeast corner of Section 23, T-1-S, R-6-W and
