AN ORDINANCE AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS OF LIBERTY COUNTY, FLORIDA, TO USE COUNTY EQUIPMENT AND LABOR FOR THE MAINTENANCE OF CERTAIN PRIVATE ROADS, AT COST; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in certain areas of Liberty County, Florida, certain citizens of said County live where the access of said homes are some distance from a paved road, and

WHEREAS, although numerous private businesses are equipped to maintain this unpaved access, the costs to the private business is transporting the equipment to maintain these unpaved access roads is such that the charge which must be made to the homeowners is prohibitive, and

WHEREAS, the County in its normal and regular maintenance of unpaved roads in the County from time to time has its equipment near such unpaved access roads and could work the said roads at a minimum expenditure of time, labor and equipment, and

WHEREAS, the Board of County Commissioners in no way intends to compete with private businesses in private road scraping, however, in the opinion of said Board, need exists in this area which cannot be economically served by private business, and

WHEREAS, by a charge made to the landowner which is sufficient to cover the costs of providing said scraping, the County can furnish such service to the landowner which is not otherwise available to the landowner and at no cost to Liberty County, Florida

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LIBERTY COUNTY, FLORIDA:

SECTION 1. The Board of County Commissioners of Liberty County, Florida, when requested to do so, is hereby authorized to use county equipment and labor for the scraping of any private road in said County and the time for which work does not exceed one hour, PROVIDED the cost thereof, referred to in Section 2 hereof, is paid to the County in advance.

SECTION 2. The Board of County Commissioners of Liberty County shall determine a charge to be made for the use of such equipment and labor in an amount which is determined by such Board to be the cost to Liberty County, Florida, for the furnishing of such equipment and labor for such purposes.

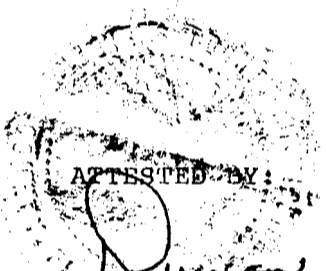
SECTION 3. This Ordinance shall take effect as provided by law.
